Summary

Bilous T. Naturalism in Contemporary Philosophy of Science. Cognitive Bases of Science. *The article examines the cognitive approach to science, which is a naturalistic approach in contemporary philosophy of science. The various cognitive naturalistic models of science inspired by artificial intelligence research and interdisciplinary cognitive science can best be understood as attempts to place methodologies on a more sound empirical footing. On naturalistic accounts, the philosophical task is to describe the cognitive capacities and dispositions that explain how and why scientists make the kinds choices of theories they do. The author also shows that the cognitive approach is an essential part of an interdisciplinary approach to science.
