Thesis of scientific report:

- + **Volume up to six (6) pages**
- + **Abstract – 500 characters,**
- + **Keywords – 5-9 words,**
- + **List of references**

Materials that do not meet the requirements, are not accepted for consideration. Authors are obliged to adhere to the principles of academic integrity, including in terms of ensuring the respective scientific level of the text of reports, the validity of conclusions, the reliability of the results. The authors are responsible for the content of the thesis's materials. The materials are not peer-reviewed or returned. Materials cannot be edited further, so they must be carefully prepared.

Requirements for thesis:

1. The volume of thesis of the scientific report - up to 6 pages of A4 format (297x210 mm); orientation - portrait; text editor - Microsoft Word, version - not lower than 6.0; all margins – 20 mm; font - Times New Roman; point size – 14; line spacing – 1,5; style – Normal; pages without numbers; do not use hard returns and additional interspaces

Alignment\width justification without center paragraph indent/No Paragraph Center, Font Style - Bold:

List of references:

For foreign scientometrical databases after the List of used literature, provide References with a separate list – according to the international standard APA (APA Citation Style); numbering – manual; – list of sources – alphabetically; width justification, no paragraph/first-line indent; font style - normal; issued according to the requirements of DSTU 8302:2015 "Information and documentation. Bibliographic reference. General requirements and rules of compilation", submitted at the end of theses. Each position in the list must be referenced in the text in square brackets. Citations at the end of page are not acceptable.
